

If you collect and remit sales or use tax, we have partnered with Xpress Bill Pay(www.xpressbillpay.com) to accept filing and payment of sales and use tax online. Your PIN is 11309. If you wish to file a paper Sales and Use Tax Return, forms can be printed from our website at www.evanscolorado.gov

One of the goals of the Evans City Council is to use our own staff to more efficiently collect the 3.5% City of Evans Sales & Use Taxes. The 3.5% City of Evans Sales Tax on all sales made on or after January 1, 2011 should be remitted directly to the City of Evans (not to the Colorado Department of Revenue).

Starting January 1, 2019, the City of Evans will require the separation of sales tax for Food for Home Consumption and the Non-Food for Home Consumption on the sales and use tax return form.

A second City Council goal is to provide more timely and accurate data of business activity in the City of Evans. Please take the time to provide us with your email address. All businesses having a 2019 City of Evans Business License will receive via email a monthly Evans Sales Tax Update that will include a summary of sales in Evans by industry type and geographic area (noconfidential business information will be disclosed).
