Enclosed for your records is your receipt and 2023 Shoshone-Bannock Tribal Business License Certificate. Please review the certificate, if there is an error, notify this department for correction. This license covers *only* the operations or activities granted. When doing business on the Fort Hall Indian Reservation you are required to follow tribal law in addition to federal laws that may apply to your business operations.

All contractors and subcontractors are required to register and obtain a Tribal Business License issued by this Department when working within the exterior boundaries of the Fort Hall Indian Reservation.

Friendly reminder when doing business on the Fort Hall Indian Reservation, sales to enrolled American Indians are exempt from Idaho Sales Tax. Idaho Sales Tax Exemption Certificate ST-101 is available at <https://tax.idaho.gov>. ST-101 Other Exempt Goods and Buyers instructions state "American Indian: Sales to an enrolled Indian tribal member are exempt if the seller delivers the goods on the reservation. The buyer's Tribal Identification Number is required. For sales of vehicles or boats, use form ST-133, Sales Tax Exemption Certificate - Transfer Affidavit."
